Knowledge of customer/prospect base, key growers, competition (including competitive products, crops, processors, and key industry influencers.) Sets clear expectations with customer on terms of sale, price, and delivery Sales of chemical, fertilizer, seed, feed, mineral, precision Ag products and customer application services. Prepares sales invoices, receives payment or obtains credit authorization. Coordinate's delivery of product for customer. Promotes new merchandise to customers. Maintain and increase current clients.
